Contest Rules: Current IJF Contest Rules Modified as Follows:

1. No Double Knee Drop Seoinage will be allowed for contestants 12 years old and under.
2. No Shime Waza (choking techniques) for 12 years old and under; if a 12 year old or under contestant is pooled with 13 year old or older contestants, choking techniques will not be allowed for all contestants in that pool.
3. Kansetsu Waza (joint lock techniques) will be allowed in the Black Belt division only.
4. Golden Score will be used if there is a tie.
5. Contest areas will be 7 meters x 7 meters, with a 4 meter safety area between contest areas and 3 meter safety zone everywhere else.
6. Care System will NOT be used; 3 referees on mat.

Scoring System:

1. The most wins; or
2. If the number of wins is tied, refer to the most points; or
3. If two contestants are tied in wins and points, then revert to the results of head to head match; whomever won the match between them will be given the higher place; or
4. If the two contestants have not competed, they will be given the option to compete.
5. If at the end of the match the contestants are tied in score, the Golden Score will be applied.
6. In all other cases not covered by these modified rules, consult with the Tournament Director.

Awards: Each pool will be awarded first, second, and third place medals.

Results will be posted on the Club web site following the tournament.

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.

2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.

5.
